CLARIFICATION OF NON-RENOUNCEABLE RIGHTS ISSUE TIMETABLE

Platypus Minerals Ltd (ASX: PLP) (**Company**) on 30 May 2016 announced the terms of its pro-rata non-renounceable rights issue (**Rights Issue**) and timetable (**Original Timetable**).

Subsequently, a change needed to be made to the Rights Issue offer document. For the purpose of effecting this change, the Company released a replacement Rights Issue offer document and associated notices this morning (6 June 2016) (**Replacement Documents**). However, the Replacement Documents contain an incorrect timetable (**Incorrect Timetable**) which should be ignored by shareholders.

Accordingly, the Company has requested a trading halt for the purpose of clarifying to the market that:

- Shareholders should ignore the Incorrect Timetable contained in the Replacement Documents released this morning;
- The Rights Issue will be conducted in accordance with the Original Timetable (including ex-date and record date) that was announced on 30 May 2016; and
- The Company will soon be releasing to the market a further replacement offer document and associated notices confirming that the Rights Issue will be conducted in accordance with the Original Timetable.
